- (a) Accept/amend agenda... It was so moved by Mike, & Second by Lisa, Motion Passed
- (b) Accept / Amend minutes It was so moved by Will, & Second by Mike, Motion Passed
- Accept/Amend Financials & Authorize Bills to be paid It was so moved by Will & Second by Rex, Motion Passed.

#### **New Business**

- Action Item: Christina Mangiapani was our guest and wanted to explain and talk about the
  upcoming Planning grants funding. We would need to have DEQ come out and tour our town then
  take their findings and write a letter of review to the funding company along with a letter of
  interest. This would all need to be turned in by Jan. 2022. She also talked about the broadband
  funding that is coming up.
- 2. Action Item: We were wondering if we would need to have A St and Terrace Ave surveyed. There are a couple of really rough estimates that were given. We tabled this till next meeting until we can get more pricing and credentials

There is also a tree the Atkins mentioned that was a hazard in the power/phone lines, and asked the city to call Avista. Mike motioned to donate the pipe to the Atkins, & contractor does the work, Lisa second the motion, Will abstained from the vote, Motion passed
- 5.
